The Parties recognize the importance of collaboration to enhance medical awareness, share resources and intellectual property, and organize seminars and webinars.

NOW, THEREFORE, the Parties agree as follows:

Objective:

The objective of this MOU is to establish a framework for cooperation and collaboration between the College and the Department of AYUSH to promote medical awareness, share resources and intellectual property, and organize seminars and webinars on relevant healthcare topics.

Scope of Cooperation:

- a) The College and the Department of AYUSH will collaborate to organize medical awareness campaigns, seminars, and webinars on traditional and holistic healthcare practices for the benefit of students, faculty, and the community.
- b) The Parties may exchange resources, research papers, and intellectual property related to traditional healthcare practices, subject to applicable laws and regulations.

Responsibilities of the College:

- a) The College shall provide suitable space and necessary infrastructure for organizing seminars and webinars.
- b) The College will actively participate in the promotion and organization of medical awareness campaigns, seminars, and webinars in collaboration with the Department of AYUSH.

Responsibilities of the Department of AYUSH:

- a) The Department of AYUSH shall provide subject matter experts and qualified professionals to deliver lectures and presentations during seminars and webinars.
- b) The Department of AYUSH will assist the College in organizing medical awareness campaigns, seminars, and webinars by providing necessary guidance, resources, and materials.

Resource Sharing and Intellectual Property Rights (IPR):

- a) The Parties may share relevant resources, research papers, and publications related to traditional and holistic healthcare practices.
- b) The Parties agree to respect each other's intellectual property rights and will not use the shared resources and intellectual property for any purpose other than the intended collaboration without prior written consent.

Duration:

This MOU shall be effective from the date first mentioned above and shall remain in force for a period of three (3) years. It may be extended or amended by mutual consent of the Parties in writing.

Termination:

Either Party may terminate this MOU by providing written notice to the other Party at least thirty (30) days prior to the intended termination date. Termination shall not affect any ongoing activities, and the Parties shall cooperate in completing any pending obligations.

Governing Law and Dispute Resolution:

This MOU shall be governed by and construed in accordance with the laws of the Republic of India. Any disputes arising out of or in connection with
