- 1. The goal is to foster collaboration, provide opportunity for educational experience, and to facilitate advancement of knowledge on the basis of reciprocity, best effort, mutual benefit, and frequent interactions. Govt. College Jaithari and Government Pandit S. N. Shukla University are agree:
 - a) to exchange information on research and educational programmes.
 - b) to jointly organize short-term continuing education programmes on topics of mutual interest and to invite each other's faculty to participate therein.
 - c) to jointly organize seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein.
 - d) if Possible to jointly propose and engage in research or training programmes sponsored by funding agencies, and to invite each other's faculty to participate therein.
 - e) to exchange, on a reciprocal basis, students at Undergraduate and Post Graduate levels for limited periods of time for purpose of education and research.
- Govt. College Jaithari and Government Pandit S. N. Shukla University agree to help identify and invite faculty members from the other institution to participate in research or student/faculty development programmes.
- Exchange students/faculties will be selected by mutual agreement between the home institution and the host institution.
- An exchange faculties/student will be considered as full-time "exchange" faculties/student at the host institution.
- 5. Govt. College Jaithari and Government Pandit S. N. Shukla University will exchange information on research and educational programmes and teaching/learning material and other literature relevant to their educational and research programmes.
- 6. Govt. College Jaithari and Government Pandit S. N. Shukla University agree to explore ways to share teaching/ learning material, and other relevant literature, while respecting each other's intellectual property and other rights.
- Govt. College Jaithari and Government Pandit S. N. Shukla University agree to help identify and invite faculty members from the other institution to participate in conferences, workshops and short-term courses.
- Govt. College Jaithari and Government Pandit S. N. Shukla University agree to share the knowledge about IPR (intellectual property rights) that arise as a result of any collaborative research or activity under this MoU will be worked out on a case- by-case basis, and will be consistent with the officially laid down IPR policies of the two institutions.

- 10. Should there be a dispute relating to any aspect of academic cooperation, Principal Govt. college jaithari and Voice Chancellor/Registrar, Government Pandit S. N. Shukla University will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.
