Objective:

Responsibilities of TP Shukla College:

- a) TP Shukla College shall designate a responsible faculty member to liaise with the College and coordinate collaboration activities.
- b) TP Shukla College will actively participate in the organization and promotion of medical awareness programs, seminars, and webinars.
- c) TP Shukla College will share relevant academic resources, research papers, and publications with the College, subject to applicable copyright laws.

Resource Sharing:

- a) The Parties agree to share access to their respective libraries, academic databases, and other resources related to medical and allied fields.
- b) The Parties agree to provide mutual assistance in obtaining intellectual property rights for innovative ideas and research outputs, where applicable.

Seminars and Webinars:

The Parties agree to collaborate in organizing seminars and webinars on topics of mutual interest, including medical advancements, research methodologies, and emerging trends in the field.

Duration:

This MOU shall be effective from the date first mentioned above and shall remain in force for a period of three (3) years. It may be extended or amended by mutual consent of the Parties in writing.

Termination:

Either Party may terminate this MOU by providing written notice to the other Party at least thirty (30) days prior to the intended termination
