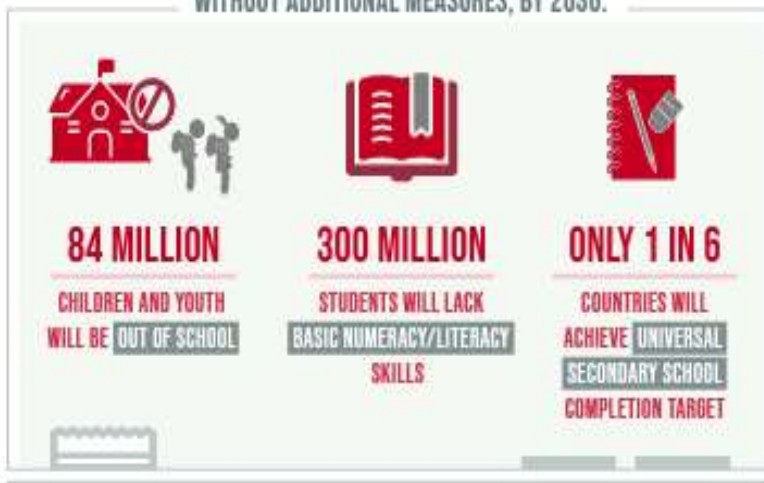

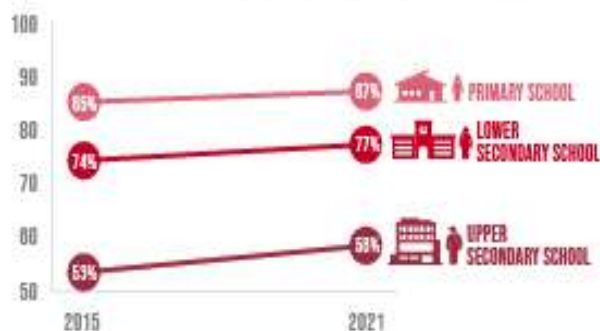
THE PANDEMIC

Anti-Ragging Policy

Introduction

Ragging in any form is strictly prohibited within the premises of the College, its departments, constituent units, and all its institutions including in any of its hostels, playgrounds, and other places of study or residence. The Govt. College Jaithari, Anuppur M.P. 484330 will take strict action including but not limited to criminal proceedings and/or cancellation of admission against those found guilty of ragging and/or of abetting ragging.

Definition of Ragging

The Honorable Supreme Court of India has defined ragging as: "Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student."

Preventive Measures

The College will take various measures including sensitization and awareness, orientation programs for students, and ensuring the mentoring of 'freshers' by teachers.

Action in case of Ragging

Any individual or collective act or practice of ragging will constitute gross indiscipline and will be dealt with under the provisions of the Indian Penal Code 1860. Depending upon the nature and gravity of the offense as established by the Anti-Ragging Committee of the College, the possible punishments for those found guilty of ragging shall be any one or any combination of the following:

- Cancellation of admission.
- Suspension from attending classes.
- Withholding/withdrawing scholarship/fellowship and other benefits.
- Debarring from appearing in any test/examination or other evaluation processes.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- Suspension/expulsion from the hostel
- Rustication from the institution for a period ranging from 1 to 4 semesters.
- Expulsion from the institution and consequent debarring from admission to any other institution for a specified period

Legal & Police Action

Under the Indian Penal Code 1860, ragging is a punishable offense and the punishment includes imprisonment, fine or both. The College will provide all necessary help in terms of manpower, information, and other resources to the police to handle the situation.

Monitoring Mechanism

The College will establish an Anti-Ragging Committee and an Anti-Ragging Squad as per the directives of the Honorable Supreme Court of India. The Anti-Ragging Committee will be the supervisory and advisory committee in preserving a Culture of Ragging Free Environment in the College Campus. The Anti-Ragging Squad will work under the Supervision of the Anti-Ragging Committee and will engage in the patrolling functions and shall remain mobile, active and alert at all times.

Responsibility

It is the responsibility of every individual associated with the College to report any act of ragging that they may come across or witness. This includes students, faculty, staff, and parents.

Awareness

The College will conduct regular awareness sessions about the dangers and repercussions of ragging. These sessions will be mandatory for all students.

Grievance Redressal

The College will establish a Grievance Redressal Committee to address any complaints or issues related to ragging. The Committee will ensure timely and effective redressal of complaints and will maintain strict confidentiality.

Affidavit

At the time of admission, every student and their parent/guardian will have to submit an affidavit to the effect that they are aware of the College's policy on ragging, the punishments, and the laws governing ragging; and that if the student is found guilty, he/she will be liable for punishment according to these rules and regulations.
