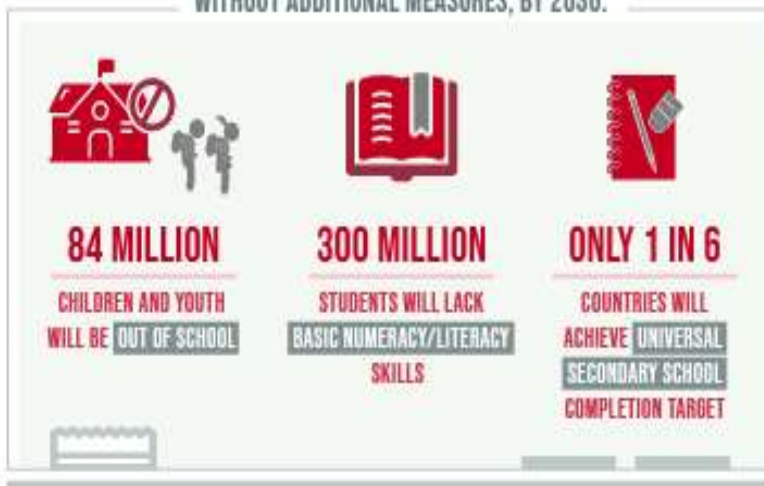

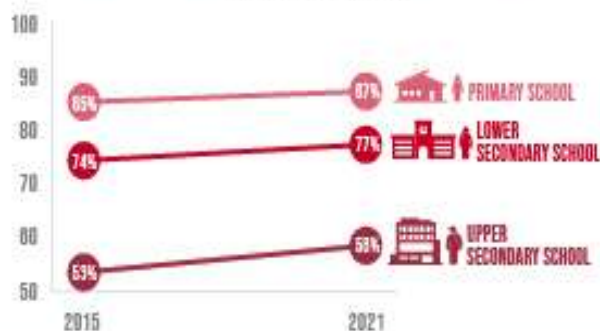
THE PANDEMIC

Examination Policy

Examination Schedule:

The college will release a comprehensive examination schedule at the beginning of each academic year, specifying the dates and times of the examinations for each course.
